- 1.3 As a DJ, you should complete the registration process by providing us with true, accurate and current information as prompted by the registration form. You should choose a secure password, you are then responsible for maintaining the confidentiality of the password and your DJ account.
- 1.4 As a DJ, Promo Push Ltd and any associated companies have the right to suspend or terminate your account and refuse future use of the service. Promo Push has the right to send relevant third party promos to registered account holders. All standard account users must obtain explicit consent from recipients, prior to commencing promotion.
- 1.5 Registered users have the right to fully unsubscribe.
- 1.6 Promo Push and the services are provided on an "as is" and available basis and we make no warranties or representations, whether express or implied to, implied warranties or conditions of completeness, accuracy or currency.
